South Borough After School Club Terms and Conditions

The charges for extended day care are published on an annual basis. The price is £8.00 per session which includes a light tea. The cost is reviewed bi-annually. Payment for extended day care is payable online via www.schoolmoney.co.uk and is required to be paid in full at the latest of the end of the week following the child's last attendance to South Borough After School Club.

Childcare vouchers

The school does not currently accept childcare vouchers for the payment of extended day care, however there are future plans to do so.

Method of payment

Please note that all payments must be made online via www.schoolmoney.co.uk

Illness/medical appointment/school closure

If your child does not attend After School Club and you have pre-paid for the session, the balance will be brought forward and not debited from your account.

Late collection charges from extended day care

If a child is not collected from school by 3.30pm, they will join after school club and the resulting charges will be applied. If a child is collected late from extended day care a charge of £3 per 5 minutes is applied. All late charges are processed at the end of each week. Parents must clear this charge by the end of the term in which the charge was incurred or their child's place will be withdrawn until payment is made in full.

Cancellation of booking

Parents are required to give a term's notice to cancel extended day care for budgeting purposes.

Payment deadlines

All sessions that your child has attended After School Club in each term must be paid for in full by the end of that term.

If payment has not been made

If the school has not received your payment, a text message will be sent home. Parents will be asked to confirm receipt of this message and make a payment immediately (within 2 days). If parent/carers are unable to clear the debt, the school will work closely with parent/carers in working out a form of payment plan to help resolve the situation (see Letter 2). If the payment plan is not adhered to or a parent refuses to agree to a payment plan, the school will not be able to provide further care from the following Monday. Once the debt has been cleared your child is welcome to resume care with payment in full in accordance with the After School Club Policy.

Terms and Conditions

I understand that priority booking is given to working parents or those studying (where we have written evidence from employers confirming working hours), exceptional circumstances and then the date which the form is returned.

I agree to pay the full cost per booking if my child attends, regardless of the pick up time.

I agree to pay £3 per 5 minutes if I am late to collect at the end of the booked session. I agree that this time is determined by the staff, using the radio controlled clock in the After School Club Area.

I understand that I am responsible for my child when I have signed him/her out at the end of the day.

I agree to pay in full before the end of each term and understand that failure to do so may lead to the provision being withdrawn.

I understand that the parent who makes the booking is liable for the charge.

I agree to pay any late charges by the deadline specified by the After School Club staff (failure to do so may lead to the provision being withdrawn)

I will ensure that any changes to the person collecting my child will be put in writing and the adult collecting will know the password.

I understand that After School Club staff cannot deal with general queries/complaints about the school or accept any payments and will direct these to the school office or Miss Ballard.

I understand that the After School Club mobile phone is only to be used in case of emergency or to notify of late collection (late charges will still apply).

I understand that if I wish to make a late booking, this must be paid for at the time of booking and a form must be completed. I understand that any adhoc bookings are subject to availability.

I understand that if I do not abide by the terms and conditions outlined above, the school will be unable to provide extended day care for my child.

I understand that by returning the booking form, I agree to adhere to the terms and conditions set out above.
